# 1. End User License Agreement ("EULA")

## 1.1. **IMPORTANT - READ BEFORE COPYING, INSTALLING OR USING**

Do not copy, install, or use the Materials provided under this license agreement ("Agreement"), until you have carefully read the following terms and conditions.

By copying, installing, or otherwise using the Materials, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, do not copy, install, or use the Materials.

End User License Agreement for the TierBroker® Middleware Server Versions 4.00 and higher.

## 1.2. **LICENSE DEFINITIONS**

"Materials" are defined as the software, documentation, license key codes and other materials, including computer source code and any updates and upgrade thereto, that are provided to you under this Agreement. Materials also include the Redistributables as defined below.

"Redistributables" are the TierBroker scripting files and example source code that is contained in the computer based training directory that is included in the Materials.

## 1.3. **LICENSE GRANT**

Subject to all of the terms and conditions of this Agreement, Hermeios Incorporated ("The Company") doing business as "Universal Data Interface Corporation" or "UDICo" grants to you a non-exclusive, non-assignable, copyright license to use the Materials.

Subject to all of the terms and conditions of this Agreement, UDICo grants to you a non-exclusive, non-assignable copyright license to modify the Materials, or any portions thereof, that are (i) provided in source code form or, (ii) are defined as Redistributables and are provided in text form.

Subject to all of the terms and conditions of this Agreement, UDICo grants to you a non-exclusive, non-assignable copyright license to distribute (except under an Evaluation License as specified below) the Redistributables, or any portions thereof, as part of the product or application you developed using the Materials.

## 1.4. **LICENSE RESTRICTIONS**

You may NOT: (i) use or copy the Materials except as provided in this Agreement; (ii) rent or lease the Materials to any third party; (iii) assign this Agreement or transfer the Materials without the express written consent of UDICo; (iv) modify, adapt, or translate the Materials in whole or in part except as provided in this Agreement; (v) reverse engineer, decompile, or disassemble the Materials; (vi) attempt to modify or tamper with the normal function of a license manager that regulates usage of the Materials; or

(vii) distribute, sublicense or transfer the source code form of any components of the Materials and derivatives thereof to any third party except as provided in this Agreement.

The scope and duration (time period) of your license depends on the type of license you purchased from UDICo. The variety of license scopes are set forth below, which may not be available for all "UDICo(R) Software Development Products" and therefore may not apply to the Materials. For more information on the types of licenses, please contact UDICo or your sales representative.

### **EVALUATION LICENSE:**

### **NONCOMMERCIAL-USE LICENSE**

If you are using the Materials under the control of a Noncommercial-Use license, you as an individual may use the Materials only for non-business use where you receive no fee, salary or any other forms of compensation. The Materials may not be used for any other purpose, whether "for profit" or "not for profit." Any work performed or produced as a result of use of the Materials cannot be performed or produced for the benefit of other parties for a fee, compensation or any other reimbursement or remuneration. You may install copies of the Materials on an unlimited number of computers provided that you are the only individual using the Materials and only one copy of the Materials is in use at any one time. A separate license is required for each additional use and/or individual user in all other cases. UDICo will provide you with a license code key that enables the Materials for a Noncommercial-Use license. If you obtained a time-limited Noncommercial-Use license, the duration (time period) of your license and your ability to use the Materials is limited to the time period of the obtained license, which is controlled by the license key code for the Materials. If you are an entity, UDICo grants you the right to designate one individual within your organization to have the sole right to use the Materials in the manner provided above.

### **STANDARD LICENSE**

If you are using the Materials under the control of a Standard license, you may install and use the Materials on an unlimited number of computers provided that only one copy of the Materials is in use at any one time for the purpose of commercial activity and/or production deployment. A separate license is required for each additional use and/or commercial production deployment. UDICo will provide you with a license code key that enables the Materials for a Standard License. If you obtained a time-limited Standard License, the duration (time period) of your license and your ability to use the Materials is limited to the time period of the obtained license, which is controlled by the license key code for the Materials.

## **ENTERPRISE LICENSE**

If you are using the Materials under the control of an Enterprise license, you may (a) install the Materials on an unlimited number of computers provided that all such computers are either owned or leased on behalf of the licensing legal entity and (b) if you are an entity you must designate from within your organization individuals to have the sole right to use the Materials, and you must limit the use of the Materials to only those designated individuals. A separate license is required for (c) each additional company or legal entity on which the Materials are used, and (d) each additional designated individual user who is not an employee or assign of the licensing legal entity.

### **1.5. LICENSE EXCLUSIONS**

All licenses include the ability to install and use the Materials on an unlimited number of computers for the following purposes.

#### **SOFTWARE DEVELOPMENT**

Using the Materials for the purpose of developing or testing TierBroker application software is permitted even if multiple copies of the Materials are in use by more than one individual at a time.

#### **USER ACCEPTANCE TESTING**

Using the Materials for the purpose of User Acceptance Testing within a non-production environment is permitted even if multiple copies of the Materials are in use by more than one individual at a time.

#### **PRODUCTION MIRRORS AND DISASTER RECOVERY**

Using the Materials in multiple copies of the production environment is permitted when those additional copies are a part of duplicates of the production environment for the purposes of a fallback mirror, backup system or disaster recovery site. No additional licensing is required as long as there is a single primary production environment which is licensed.

### **1.6. DISTRIBUTION**

Distribution of the Materials is also subject to the following limitations: You (i) shall be solely responsible to your customers for any update or support obligation or other liability which may arise from the distribution, (ii) shall not make any statement that your product is "certified", or that its performance is guaranteed, by UDICo, (iii) shall not use UDICo's name or trademarks to market your product without written permission, (iv) shall prohibit disassembly and reverse engineering, (v) shall not publish reviews of Materials designated as beta without written permission by UDICo, and (vi) shall indemnify, hold harmless, and defend UDICo and its suppliers from and against any claims or lawsuits, including attorney's fees, that arise or result from your distribution of any product.

### **1.7. SOFTWARE TRANSFER**

You may permanently transfer all of your rights under this Agreement only with UDICo's prior written permission.

## **1.8. COPYRIGHT**

Title to the Materials and all copies thereof remain with UDICo or its suppliers. The Materials are copyrighted and are protected by United States copyright laws and international treaty provisions. You will not remove any copyright notice from the Materials. You agree to prevent any unauthorized copying of the Materials. Except as expressly provided herein, UDICo does not grant any express or implied right to you under UDICo patents, copyrights, trademarks, or trade secret information.

**NO WARRANTY AND LIMITED REPLACEMENT: THE MATERIALS AND INFORMATION ARE PROVIDED "AS IS" WITH NO WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT OF UDICOLECTUAL PROPERTY RIGHTS, OR ANY WARRANTY OTHERWISE ARISING OUT OF ANY PROPOSAL, SPECIFICATION, OR SAMPLE.** If the media on which the Materials are furnished are found to be defective in material or workmanship under normal use for a period of ninety (90) days from the date of receipt, UDICo's entire liability and your exclusive remedy shall be the replacement of the media. confidentiality obligations with respect to the Communications. You agree that UDICo and its designees will be free to copy, modify, create derivative works, publicly display, disclose, distribute, license and sublicense through multiple tiers of distribution and licensees, incorporate and otherwise use the Communications, including derivative works thereto, for any and all commercial or non-commercial purposes.

### **1.12. TERMINATION OF THIS LICENSE**

This Agreement becomes effective on the date you accept this Agreement and will continue until terminated as provided for in this Agreement. If you are using the Materials under the control of a time-limited license, for example an Evaluation License, this Agreement terminates without notice on the last day of the time period, which is controlled by the license key code for the Materials. UDICo may terminate this license at any time if you are in breach of any of its terms and conditions. Upon termination, you will immediately return to UDICo or destroy the Materials and all copies thereof.

### **1.13. U.S. GOVERNMENT RESTRICTED RIGHTS**

The Materials are provided with "RESTRICTED RIGHTS". Use, duplication or disclosure by the Government is subject to restrictions set forth in FAR52.227-14 and DFAR252.227-7013 et seq. or its successor. Use of the Materials by the Government constitutes acknowledgment of UDICo's rights in them.

### **1.14. APPLICABLE LAWS**

Any claim arising under or relating to this Agreement shall be governed by the internal substantive laws of the State of Delaware, without regard to principles of conflict of laws. You may not export the Materials in violation of applicable export laws.
